## ANNEX 2 - CONSENT FORM FOR PROCESSING DATA

(This Consent Form shall be governed by the Data Protection Act 2017)

I, understand and agree that Ariva Ltee including its subsidiaries as “The Group” shall, for the performance of its obligations hereunder, collect and where necessary or required, process and store my personal data which I hereby voluntarily disclose for as long as is necessary to fulfil the purposes for which it was collected, including for the purposes of satisfying any legal, accounting or reporting requirements.

### Your rights

I, hereby acknowledge that the Group has informed me, as data subject, of the provisions of the Data Protection Act 2017 namely the right;

1. To access to, to request rectification and erasure;
2. To object to the processing;
3. To withdraw consent at any time, without affecting the lawfulness of processing based on the consent which I have provided prior to my withdrawal.
